

# TUITION AND FINANCIAL INFORMATION

**ONLINE APPLICATION PROCESSING FEE: \$80.00 PER FAMILY (Non-refundable)**

**REGISTRATION FEE: (Non-refundable)** Tuition rates do not include the annual registration fee, which is \$185 per **returning** student with a deadline of February 25, 2022, or **\$200.00** per returning student if **after** February 25, 2022. **The registration fee for new students enrolling in their first year is \$200.00.**

**HIGH SCHOOL CHROME BOOK FEE: \$200.00 yearly for all 9<sup>th</sup> -12<sup>th</sup> graders (Non-refundable)**

**TUITION:** Tuition covers most costs, including books, accident insurance, K-8 testing, PSAT/pre-ACT tests, and facility usage fee. Tuition can be paid monthly or yearly (by June 1, 2022). All Academy families must establish a BLACKBAUD TUITION account. Information and sign-up for BLACKBAUD TUITION is located on the HPCA website at [www.hpcacougars.org](http://www.hpcacougars.org). You may choose either a 10-month payment plan or a 12-month payment plan. You may also choose the draft date from several options. All tuition payments will start in June of each year. On the 10-month plan, the payments will be June-March. On the 12-month plan, payments will be June-May. The annual fee for this service is **\$50.00 PER FAMILY** (this amount will be drafted by BLACKBAUD TUITION).

**NEW STUDENT TUITION DEPOSIT: \$250.00 PER STUDENT** (non-refundable) until June 1. After **June 1, the tuition deposit becomes the first of 12 payments; students enrolled July 1, the first of 11 payments; and students enrolled August 1, the first of 10 payments.** The deposit will be applied toward the yearly tuition. This deposit is in addition to the registration fee.

**ANNUAL TUITION DOES NOT INCLUDE:** lunches, after-school care, field trips, yearbooks, athletic fees, PE/school uniforms, AP exams, HS online classes, K-8 Resource services, senior fees, athletic participation, etc.

**TUITION ASSISTANCE:** A limited amount of financial aid is available yearly for which families may apply; proof of financial need is required. There is a **\$35 fee** to apply through BLACKBAUD Tuition Aid, the third party administering this aid. The **deadline** for applying for financial aid is **March 15 for current families**. Applications submitted after that date will also be reviewed by BLACKBAUD Tuition Aid, who will determine if applicants are eligible and, if so, the amount will be based on the amount of assistance remaining. **WITHDRAWAL FEE: \$1000.00 PER STUDENT (TK – 12<sup>th</sup> grades)** - Students are considered enrolled for the entire school year; therefore, budgets and teacher contracts are set accordingly. The early withdrawal of student(s) creates an opening, which HPCA may not be able to fill with a viable candidate. **Student(s) who withdraw anytime between July 1, 2022 and May 31, 2023 will be assessed a \$1000.00 Withdrawal Fee. In addition, the full month’s tuition is due for any month in which the student(s) attends school one day.** All fees are due in full and are non-refundable. Refunds are for tuition only, and will be made on accounts that are paid beyond the current month. Official transcripts, report cards, and records cannot be released or sent to other schools with an outstanding balance remaining at HPCA.

**TUITION REFUNDS:** There will be no refund for absences from school. Exceptions will only be made in the case of hospitalization of your child with a serious illness. A doctor’s note is required.

**SUSPENSION FOR NON-PAYMENT:** Students may not be allowed to attend class when their accounts become 30 days delinquent. Students are subject to dismissal if their account is not brought current within one week of their suspension. Students will be suspended only once during a school year for a delinquent account. A subsequent suspension for non-payment may result in the student’s dismissal from HPCA.

**AFTERSCHOOL REGISTRATION FEE: \$30.00 PER STUDENT ( Non-refundable)**

**AFTERSCHOOL CARE:** Afterschool care is paid monthly through your Smart account. The first payment is due September 1, 2022 and the final payment is due May 1, 2023. Our afterschool hours are from 2:15 to 6:00 p.m. for TK – 6<sup>th</sup> grade. Families will be charged \$1.00 for every minute a child remains in afterschool care after 6:00pm.
